Frequently, the CRTs are so damaged that neither a correct nor a reasonable treatment can be fulfilled. Despite this widely known subject, no actor in the sector takes any action. Why that?

Belgium: New product list in force.

On the 1st July 2010, RECUPEL has published a new product list that aligns even closer with Directive 2002/96/EC. Also EEE for professional usage is included.

Denmark: No costs for RENE B2C customers up to September 2011.

With regard to the past collections in RENE Denmark and the new customer structure, the Danish dpa-system has liberated RENE from any municipal collection obligations for the coming compliance period. Due to the start of the new period on the 1st September, the RENE B2C members in Denmark will face no collection-related costs until the 31st August 2011.

Germany: ear presidency for EWRN

The German register ear has taken over the presidency of the European WEEE Registers Network (EWRN) and has taken the turn from Belgium.

Italy: Does the revision of Decree 152/2006 link to SISTRI?

Italy foresees a revision of Decree 152/2006. Voices in the sector say that a part of this revision is a linkage between Decree 65/2010 and the waste transportation tracking system SISTRI. Seemingly, actors that are concerned by Decree 65/2010 <u>may</u> use SISTRI at the same time. At present, there is no official confirmation yet.
