Commodities: Raw materials are rising – Steel prices are declining

Our partner for raw material reports, the IKB Deutsche Industriebank AG, (www.ikb.de) announced a small increase in the global prices for raw materials throughout July, especially for precious metals. On the other hand, the prices for steel and scrap metal declined slightly. A trend reversal is not expected until September.

According to its own statements the Italian recycler Relight recovers in his pilot plant yttrium and indium from television tubes and fluorescent tubes with a degree of purity of 97 %. The industrial production will start in 2013. Yttrium and indium belong to the popular rare earth metals.

Germany: RoHS 2.0 in force

The revision of the RoHS-directive (2002/95/EG) came into force on the 21st July 2011. The deadline for the transposition into national law is set for the 2nd January 2013. From 2014 on the directive will embrace medical devices and from 2017 on monitoring and control instruments as well.

UK: Authority and systems in dialogue.

In spring the British Authority EPA asked all compliance schemes to give their feedback on the changes in the viable plan documents. The viable plans are a considerable element for the British regulator for the control of the reverse flows. Further discussions will be conducted at a workshop on the 9th July 2011.
