Commodities: Record in 2011, growth as well in 2012.

Our partner for raw material reports, the IKB Deutsche Industriebank AG, (www.ikb.de) has announced in November that the global production of steel is expected to reach the record level of 1.5 billion tons. China still beats the drum with the highest impact on demand. A growth is assumed also for 2012, even though slighter than in 2011. The prices for scrap fell again in November 2011. The exports of scrap to Turkey reamain restrained. An increase in scrap prices is possible until the end of the year and during first quarter.

Producer responsibility: No agreement on WEEE-Recast.

The so called "Trialogue" on the 29th November 2011 did not lead to an agreement between the involved parties (European Parliament, Council of Ministers, Commission). An additional appointment is scheduled for the 20th December 2011. First voices are assuming that there will be no progress on the topic. Especially the definition of collection quota seems to be a barrier. If no agreement is compassed, the WEEE-Recast will be postponed for years.

The Recycler's View: Who cares about deliveries?

How could it be that containers are still at the forwarder's sites two months after picking-up from the municipality? Why is it not important that producers are reminded many times by the central register ear due to not fulfilled output declarations? RENE AG has been forced to set contractors under pressure to get containers taken to recycling. The pick-ups from municipalities are normally proceeded without problems. To big is the fear to be fined by ear. The declaration relevance of producer seems to be not interesting for hardly anybody due to missing consequences. Corresponding contradictory are statements in the return chain after the pick-up if no consequent management occurs. "We have already delivered the container" is the most innocent version. This shows once more, that a comprehensive, independent order, data and finance management is obligatory on disposal. "You get what you measure" says an American management saying. Obviously we require more measuring points – or at least a more extensive schedule of penalties.

Germany: Draft for ElektroGKostV published.

The draft for the forth regulation on changing the cost ordinance of the law for electrical- and electronic equipment (ElektroGKostV) is visible on the homepage of the German Ministry for Environment. According to this, fees for each element will be reduced remarkable. The introduction is assumed to take place throughout next year.

The radio station Ö3 is collecting old mobile phones from private households in cooperation with the post, according to own statements the seventh time. For this, the post delivered envelopes to all 3.6 million households in Austria. 1056 schools in Austria have collected already 20556 old mobile phones. Each mobile phone which was sent back cost-fee will be reimbursed. The proceeds will be donated to charity.
