Our partner for raw material reports, the IKB Deutsche Industriebank AG, (<a href="www.ikb.de">www.ikb.de</a>) announced fluctuating global prices for raw materials in October, resulting from the situation in the Euro-Zone as well as expectations of a global economy downward trend in 2012. The global production of steel increased due to the demand from China by 8 % in September. Ridiculously low prices for iron ore collapsed by a third in October. The prices for scrap and steel decreased as well. However the IKB is predicting stable global steel prices for November.

# Producer responsibilty: Trialogue upon recast.

The pressure upon the EU environment ministers and MEPs is increasing. Environmental pressure groups, NGOs and lobbyists are strongly demanding massive adaptations in the targets laid out in the WEEE recast. Focus is put on product design, collection and treatment rates. A trialogue between the actors is scheduled for the 29th November 2011 and it is hoped that a resolution will be found shortly afterwards.

## Germany: Recycling and waste disposal law favours municipalities?

The amendment of KWAG is supposed to supersede the "yellow sack" with a "recycling bin", in which plastic waste and waste metal can be disposed. Voices from the waste sector are making complaints; the introduction of this law would be dominated by competences not by environmental aims. It is feared, the municipalities will have too much advantages.

#### France: New regulations on metal trade.

Buyers of metal are going to have to declare the data of sellers and the volumes to the tax office from 1<sup>st</sup> January 2012 on. Since 31<sup>st</sup> July 2011 sales of ferrous- and non-ferrous metal are not allowed to be carried out cash.

#### Netherlands: Wecycle raises prices significantly.

The members of "Stichting Bruingoed" have been informed, that after the omission of the visible fee in February 2011, the costs for recycling are to be dealed with the respective take-back system. The system has announced massive price increases for 2012. 80 % of the increased will be covered by the usage of savings. Nevertheless the costs for the affected producer will be significant higher above the level of 2011.

## Spain: Auditing of system registrations and sales data

Last month the government of Catalonia has verified the membership of producers in take-back systems for batteries. On this, it was noticed that not all systems had the necessary geographic covering. Just the membership in any take-back system is not enough for the release.

During the auditing of sales quantity data, the basis of the raw data as well as the consistency of declarations to the system and the carryover to the Spanish central register had been verified.
