# Commodities: Steel production shoots for all time high with prices increasing slowly.

Our partner for commodity reports, the IKB Deutsche Industriebank AG, (www.ikb.de) announces a decline in global prices for raw materials for August on dollar basis of more than 5%. The global steel prices decreased by 3%, the prices for scrap remained – now for four months – stable. This is due to the turbulences in the financial market and the worry that those will affect the real economy. In contrast, the global steel production rose by 8 % in July. Responsible for the growth is still China, which is expected to reach an output level of 700 million tons at the end of the year. A worldwide production volume of 1.5 billion tons of crude steel is expected by the end of the year for the first time ever.

## No compromises on WEEE Recast collection target

European Parliament Delegate Karl-Heinz Florenz published his recommendation for the second reading of the revision of the WEEE-Directive. According to his position paper the essential targets of the "recast" are not to be softened. Florenz especially requires to retain the determination for a collection target of 85 % by 2016.

## The Recycler's View: Increasing public awareness upon cat 5 recycling

Since the 1st September 2011 60-watt-light bulbs are banned from the German market. Obsolete bulbs have to be replaced by LED-lights and energy saving electric bulbs. According to a survey of the German take-back system Lightcycle, 73 % of the interviewees know how to dispose the lamps. Almost half of them would dispose obsolete lighting equipment at a municipal collection point. One out of every five would use a collection box displayed in retail shops.

Private end-users still lack information upon the return locations for WEEE, the treatment processes and the responsibilities behind all this. Particularly small WEEE is therefore often ending in the regular unsorted domestic waste stream. Partially, private households hand their WEEE also over to "resellers".

The central coordination office finished the allocation of the collection stations to the takeback-systems on the basis of the declarations of the year 2010. As a result the systems are now able to optimize their infrastructure.

An appropriate arrangement came into force by law decree no. 138 of 18<sup>th</sup> August 2011 with immediate effect.

## Malta: Authority outlines WEEE guidance plan

"A plan to provide guidance to stakeholders managing Waste Electrical and Electronic Equipment (Weee) has been developed by the Malta Environment and Planning Authority (Mepa). The plan highlights Malta's commitments under European legislation, in particular the achievement of re-use, recycling and recovery targets. It identifies the roles and responsibilities of the various economic operators, and outlines the infrastructure and financial measures deemed necessary to manage Weee generated locally. Public consultation on the draft Weee plan is being carried out jointly by the Office of the Prime Minister and Mepa."
