## Commodities: Continuous increase.

Our partner for raw material reports, the IKB Deutsche Industriebank AG (<u>www.ikb.de</u>), also confirms in February the forecast of inclining prices at European steel products for Q1. In January the scrap prices tended to move sideward while the prices for ore rose.

#### The Recycler's View: re-introduction of official controls

The British Environment Agency controls since December 2012 about 20 designated collection facilities (DCF) to identify potential wrong collections of used electrical appliances. This measure addresses the problem of "Leakage", the non-controlled and partially illegal collection of used appliances.

### Germany: EAR- fee supposed to rise.

Due to the increasing opting out of the municipalities in the range of the German ElektroG, the number of the administrating official take-back orders has significantly declined. The workforce of the Stiftung elektro-altgeräte-register © remains the same. Therefore, the fees for take-back and provision orders are to be risen slightly by 40 %.

#### UK: Games consoles belong to WEE- category 7.

With the start of the compliance period 2013, games consoles have to be declared in the WEEE-category 7 in UK. The authority takes note that consoles are also be used as multimedia devices, contains hard drives and have access to the internet. But they are, however, toys, sport and leasure equipment.
